NCJ 2020 Event Keynote Speaker: Bishop Tracy S. Malone is the Resident Bishop of the Ohio East Area, which includes the East Ohio Conference in the North Central Jurisdiction of The United Methodist. She was elected to the Episcopacy in 2016.

She currently serves as president of the General Commission on the Status and Role of Women and is a member of the Board of Trustees at Garrett-Evangelical Theological Seminary. As resident bishop, she also serves on the Boards of Trustees at our United Methodist-affiliated colleges, seminaries and organizations in East Ohio.



NCJ 2020 Event Spiritual Guide: Rev. Dr. Michele E. Watkins serves under appointment as the Assistant Professor of Theology and Religious Studies at the University of San Diego, teaching courses in the early church tradition Black and Womanist theologies, and Religion and Hip-Hop.

Dr. Watkins' is presently working on her monograph tentatively titled Deification for the Desacralized, which places Womanist theologians in conversation with Greek patristics and Orthodox Theology to construct a meaningful interpretation of the Eastern doctrine of thesis.
