Instructions can be found on line: no sew blanket or knotted blanket. Match the pieces with right sides facing out. Pin to hold in place. Use sharp scissors to cut 5x5 inch squares from each corner. Cut 1x5inch fringe along each edge. Gently tie double-knots along each side.

In June, United Women in Faith Prairie Central will be visiting SCARCE, 800 S. Rohlwing Rd., Addison on Saturday, June 22, 2024 at 10:00 a.m. What is SCARCE, you ask? SCARCE is an award-winning environmental education non - profit dedicated to creating sustainable communities. The organization accomplishes this through innovative and hands-on education programs for schools and organizations, demonstrating care for people and our natural resources through their Reuse Center, and engaging the broader public through community - wide events and programs.

For over 30 years SCARCE has been implementing change to foster a more sustainable future. SCARCE began when Executive Director, Kay McKeen, was teaching in DuPage County schools about recycling and other environmental issues and concerns. Kay was out teaching when she realized that many schools had countless textbooks just sitting in storage, taking up space. All the while, the information was becoming obsolete, it was costing the schools money for the books to sit in storage AND they were going to end up in the landfill! Therefore, in 1991 she started the Book Rescue with the idea of "rescuing" gently used books (text, reference and library) from going in the landfill, and instead putting them into the hands of those who need them. A visit to their website will give you an idea of how they have expanded into many other environmentally friendly projects!

One of them is the recycling of bread bag tags, so start collecting them and bring them along with you!



History

On the evening of Tuesday, June 4, 1979, **Resolution 741** was adopted creating United Voices for Children (UVC) on the floor at the Annual Conference. For 45 years, UVC has continued advocating on behalf of children, youth, and families for its three affiliated child-serving agencies, Rosecrance, Kids Above All (formerly ChildServ), and MYSI (formerly Methodist Youth Services Inc). The 5 th Sunday Appeal started in 1981 with the special offerings that year totaling \$34,361.00, as stated by Rev. Margaret Ann Williams in a January 18, 2008, document called *UVC 'Looking Back'*.

Since its inception, established as a 501(c)(3), not a conference committee, UVC has been serving in the capacity of 1) a catalyst for generating support and engaging congregations in advocacy, and 2) a conduit through which information and resources are exchanged between congregations and the agencies. This history stresses that the role of UVC is different from many other organizations in that it provides no services for its own sake, yet serves to generate support in making vital connections for information and resources to build bridges from the UM local churches to the agencies and throughout the NIC for kids and families.

A New Day

Every petition submitted by United Women in Faith to the 2024 United Methodist General

Conference has moved forward: 18 have passed committee, and one has passed subcommittee and will be voted on by the full committee. We are thrilled the church supported women and children in this way, and we look forward to the same support by the full body.

The 18 petitions that passed committee all had fewer than 10 votes against them, so this allows those petitions to appear on a consent calendar, which is a collection of multiple pieces of legislation on which the General Conference can vote on all at once. The plenary will vote on them in the coming days.

The General Conference also voted to begin worldwide regionalization! Five petitions presented by the Standing Committee on Central Conference Matters passed the full body on Thursday. <u>United Women in Faith supports regionalization</u> as a faithful path forward for our church.

May the doors remain open for the Holy Spirit to ever and powerfully present.

Deaconesses and home missioners are laypeople who are called by God to be in a lifetime relationship in the UMC for engagement with a full-time vocation in ministries of love, justice, and service. They form a covenant community that is rooted in Scripture, informed by history, driven by mission, ecumenical in scope, and global in outreach. Their community dates back to the late 19th century. (Deacons are clergy who are ordained to word, service, compassion, and justice.) Congratulations, Barbara!
